PRIVACY POLICY

Pursuant to article 13 of the Italian Legislative Decree of 30 June 2003, no. 196, which imposes the obligation to inform the person concerned about the fundamental elements of processing, the undersigned company **ICMQ S.p.A.**, having its registered office in Milan, Via G. De Castillia 10, fulfils said obligation by informing you that the data concerning you, either provided by you or otherwise acquired during our statutory activities, will be handled in accordance with the standard mentioned above and the obligations of confidentiality inherent in our organisation's work.

This data will be processed for purposes related to the economic activities carried out by us and in particular:

- for requirements prior to entering into a contract;
- to give effect to a deed or one or more contractually-agreed operations;
- to give effect to the formalities relative or instrumental to the contract with any public or private body;

- to bodies, consortia or associations established for the purposes of credit protection;
- to companies controlled by our institution for our pursuit of the aforementioned purposes;
- in the cases provided for by law.

The provision of data from you is:

- Mandatory according to law, regulation, EU legislation; in these cases, your refusal will result in our inability to fulfil our contractual obligations;
- Conditioned by the ability to effectively carry out contractual obligations; in these cases, your refusal will affect the quality and effectiveness of fulfilment;
- Optional for the purpose of sending advertising and/or promotional material; in these cases, your refusal will mean we will be unable to send you advertising material and/or carry out promotional activities.

In relation to the aforementioned processing, you are entitled to exercise the rights referred to in article 7 of Italian Legislative Decree 196/03, including, in particular, to obtain the erasure, updating, rectification or integration, opposing the processing of data obtained unlawfully or for purposes of commercial information, sending of advertising material, direct sales, interactive commercial communications.
